- I. Anna Hayden, DO, called the meeting to order at 6:02 AM. Dr. Hayden presented the agenda for approval. Joseph Zammuto, DO, made a motion to approve the agenda; seconded by Bridget Bellinger, DO. The agenda was adopted unanimously.
- II. Dr. Hayden presented the January 8, 2016 meeting minutes and asked if any amendments would be offered. There were none. Ernest Miller, DO made a motion to approve the minutes; seconded by Barbara Walker, DO. The minutes were adopted unanimously.
- III. Organizational Comments
 - a. American Osteopathic Association (AOA)
 - i. Boyd Buser, DO, AOA President-elect, provided an update on the AOA's strategic plan.
 - ii. Dr. Buser provided a status report on the Single Accreditation System (SAS). The AOA continues to collaborate with Accreditation Council for Graduate Medical Education (ACGME) as they administer the infrastructure with the five year transition of AOA accredited programs into the new system. The osteopathic standards were added to ACGME, and "osteopathic recognition" within the ACGME structure will be a very important framework for osteopathic graduates.
 - iii. He also informed the fellows that both DO and MD graduates will be eligible for all residences in the SAS. American Association of Colleges of Osteopathic Medicine data reveals 5,400 graduates are seeking graduate medical education positions and 99.6% are placed into slots.
 - b. National Board of Osteopathic Medical Examiners (NBOME)
 - i. Gary Slick, DO and John Gimpel, DO, MEd, provided an update on their organization and the COMLEX-USA. Dr. Gimpel reported that of the 6,200 first time test takers -92% passed. The COMLEX-USA tests the humanistic, biomedical and biomechanical domains.
 - ii. The NBOME is also excited about their ribbon cutting ceremony for a second clinical skills testing site. Students will now have an opportunity to complete their clinical exams either in Conshohocken, PA or in Chicago, IL. The Chicago testing site is scheduled to open on August 26, 2016.
 - c. Federation of State Medical Boards (FSMB)
 - i. Humayan Chaudhry DO, MACP, CEO of FSMB gave welcoming remarks, and discussed new and ongoing initiatives and services undertaken by the FSMB.
 - ii. Dr. Chaudhry provided updates on the uniform application, Federation Credential Verification Service, member portal, and the ability of the public to view information about their doctor on the physician data center.
 - iii. Two new workgroups have been established to educate students, resident and physicians on medical regulation and about the licensure process. The newest one, The Physician Burnout Workgroup, has been developed by current FSMB Chair, Art Herenger, MD, as the statistics reveal that the physician death rate as a result of suicide are the highest in all professions.

- IV. Dr. Hayden brought forth issues related to the 2016 FSMB Annual Meeting
 - a. Resolutions being presented during FSMB's annual meeting were reviewed and discussed.
 - b. Geraldine O'Shea led the discussion on FSMB candidates for election to various offices.

- V. Dr. Hayden facilitated the Osteopathic Medical Regulation/Licensure Roundtable. The discussion was centered around a draft template for an Osteopathic Medicine Equivalency Act to be used by each state.

- VI. Dr. Hayden announced two future meeting dates for the AAOE.
 - a. The organization will meet July, 2016 in conjunction with the 2016 AOA Annual House of Delegates in Chicago, IL.
 - b. The AAOE Summit will be held in January 2017 and are awaiting a confirmation on date and location.

- VII. Dr. Hayden, seeing no additional comments, asked for a motion to adjourn. Dr. Steingard made a motion to adjourn; seconded by Dana Shaffer, DO. Motion was unanimously adopted. Meeting adjourned at 8:05 AM.

The American Association of Osteopathic Examiners (AAOE) Annual Meeting was held on April 29, 2016 at the Manchester Grand Hyatt in San Diego, California. This meeting was held in conjunction with the Federation of State Medical Boards (FSMB) Annual Meeting.

Humayan Chaudhry DO, MACP, CEO of FSMB gave welcoming remarks, and discussed new and ongoing initiatives and services undertaken by the FSMB as it works with and for its members to improve the quality, safety and integrity of health care. Dr. Chaudhry provided updates on the uniform application, Federation Credential Verification Service, member portal, and the ability of the public to view information about their doctor on the physician data center. There were two newer workgroups established to educate students, residents and physicians on medical regulation and about the licensure process. The Physician Burnout Workgroup is the newest one developed by Current Chair of the FSMB, Art Herenger, MD, as the statistics reveal that the physician death rate as a result of suicide are the highest in all professions.

Gary Slick, DO, Chair of the National Board of Osteopathic Medical Examiners (NBOME) and John Gimpel DO, MEd, President & CEO, provided an update on their organization and the COMLEX-USA. Dr. Gimpel reported that of the 6,200 first time test takers -92% passed. The COMLEX-USA tests the humanistic, biomedical and biomechanical domains. The NBOME announced their ribbon cutting ceremony for a second clinical skills testing site. Students will now have an opportunity to complete their clinical exams either in Conshohocken, PA or in Chicago, IL. The Chicago testing site is scheduled to open on August 26, 2016.

Boyd Buser, DO, President–elect of the American Osteopathic Association (AOA), gave an update on the Single Graduate Medical Education Accreditation System. The ACGME will administer the infrastructure to assist osteopathic graduate medical education programs, and July 1, 2015 began the five year transition of AOA accredited programs into this new system. The osteopathic standards were added to ACGME, and “Osteopathic recognition” within the ACGME structure will be a very important framework for osteopathic graduates. Both MD and DO graduates will be eligible for all residences in the single accreditation system. AACOM data reveals 5,400 graduates are seeking graduate medical education positions and 99.6% are placed into slots.

It was a well-attended meeting with 36 fellows present. Our next AAOE meeting is scheduled during the AOA House of Delegates meeting in Chicago this July. Information will be forthcoming.
